No. The cash outflows for the December 2023 quarter were inflated due to the early redemption and conversion into shares of 60% of the Convertible Notes on issue. This will result in reduced cash outflows for future quarters.	
2. Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?	
The Company has the ability to place the shortfall from the recent entitlement issue of up to 175,554,539 shares at 3.0 cents per share or higher by 11 March 2024 in addition to the Company's available placement capacity under Listing Rules 7.1 and 7.1A. The Company also has the ability to reduce operating expenses and raise additional capital if this becomes necessary.	
3. Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?	
Yes, the company expects to be able to continue to operate on a going concern basis.
