SECTION 708A NOTICE AND APPENDIX 3B

On 15 March 2017, Nagambie Resources Limited (“**Company**”) issued a parcel of 2,366,667 new fully paid ordinary shares in the capital of the Company (“**New Shares**”) at an issue price of A\$0.06. 
