
SHARE PURCHASE PLAN – CLEANSING NOTICE

On 16 October 2019, Nagambie Resources Limited (*Company*) announced that it will conduct a Share Purchase Plan (*SPP*) to provide eligible shareholders with the ability to subscribe for up to A\$30,000 of new fully paid ordinary shares in the capital of the Company (*New Shares*) at an issue price of A\$0.053 each (subject to conditions).

4. As at the date of this notice, there is no excluded information (in accordance with the requirements of subsections 708A(7) and (8) of the Act as if this notice were a notice under paragraph 708A(5)(e) of the Act).
